It will be a long time before there is relief from the pain. Life will never be the same. Relationships will change, weaken or strengthen. School has to start, businesses have to rebuild life has to go on.

Jared Brown recounts Polio Plus Status in the World

Past Rotary 6950 District Governor, Jared Brown, addressed the Rotary Club of Seminole Lake about how The Rotary Foundation has changed the world, specifically with the \$15 Billion raised by Rotary and subsequently the World Health Organization and the Bill and Melinda Gates Foundation in bringing the 350,000 cases of polio recorded in 1979 to only 7 this year to date. The four countries still recording this small num-

ber of cases of polio needing to be reduced to zero in order to state that this dreaded disease is truly eradicated are: Afghanistan, Pakistan, Nigeria and New Guinea. The estimated amount of future funds needed to accomplish this task is pegged at \$1.5 Billion. Since Rotary started this process in 1979 and officially announced the Polio Plus Program in 1989, the financial and hu-



man volunteer efforts to inoculate the millions of children each year have been extraordinary and exemplary of "Service Above Self" that serves as the Rotary International motto.

Jared also mentioned that District 6950 has been an annual world leader in raising money for The Foundation, and raised over \$500,000 last year! He congratulated the Seminole Lake Club for the

\$15,000 they raised and the very impressive amount of \$311 per capita-also one of the leading Clubs in the District in this area.
