1. I am currently in the 11th grade or Junior Class of my high school or a Foreign Youth Exchange Student from the country of _____.
2. I will attend the entire RYLA conference, from Friday, 2:00 pm to Sunday, 12:00 noon.
3. I will honor the Dress Code. Coat and tie for men and equally appropriate attire for ladies. This begins with travel to and arrival at the RYLA Conference. For ladies, equal attire is defined as a dress, business suit, or a pant suit. Acceptable attire for excursions to Fort Macon or the Aquarium can be the same as for the Conference or neat slacks, shirts with collars, blouses. Also warm jackets. After all, it is January in North Carolina. Acceptable attire for the after evening sessions for fellowship, dancing, pizza, TV watching, playing the piano, and the DJ sessions is the same as stated above for the excursions except that jeans (neat and casual) are permitted. **No Tank Tops, No Hanging Pants.**
4. I will conduct myself in a responsible manner, respecting Rotary Counselors' suggestions, honoring state and federal laws pertaining to the use of alcoholic beverages and illegal drugs while maintaining high ethical and moral conduct.
5. I understand rooms and areas occupied by delegates of the opposite sex are off limits. Definition: Men do not visit in rooms or areas occupied by women, and women do not visit in rooms or areas for men.
6. I will not leave Trinity Center and/or RYLA designated area after arrival until the conference ends, except for official RYLA programs.
7. I will wear my name tag properly from registration until the conference ends, just below the right shoulder.
