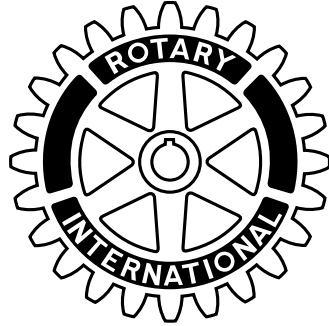

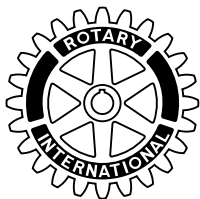

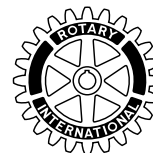

Speech Guidelines

- The Four-Way Test speech should run between 4-3/4 minutes and 7-1/4 minutes in length.
- **The speech should incorporate the Four-Way Test as it might apply to how we should conduct ourselves in business, school, or any aspect of our daily lives.**
- Students entering the contest have the creative license to develop a speech that focuses on whatever aspect of life he or she wishes.
- Implementation of The Four-Way Test should run throughout the speech. All four points or questions in the test should be verbally mentioned.
- Students may choose to follow the traditional speech format, whereas others might opt for more of a story-telling format.
